Spearfish Creek Group require the following to be available at all events:

- 1) Roped off area/arena no smaller than 120 foot long by 60 foot wide, this is for health and safety reasons, our guns used are blank firers or black powder so can be dangerous, hence the public must be behind ropes at all times during shows/ gun fights.**
- 2) Close by Water supply for fire risks and drinking water.**
- 3) Toilets.**
- 4) For two/three day events, which means we will be staying over night in the tents, we would need a fire wood supply. This does not apply to one day events.**

Terms and Conditions:

- 1) Please note that by signing and sending back this form to Spearfish Creek, that you are confirming a booking with Spearfish Creek Re-enactment Group and its members.**
- 2) Your are agreeing to the above list of our requirements.**
- 3) You agreeing to our cancellation policy as per below.**
- 4) You are agreeing to pay Spearfish Creek Re-enactment the applicable fee, this fee is payable on arrival of Spearfish Creek at the event booked, by cash or cheque only, cheques payable to Spearfish Creek.**
- 5) You will also consult the co-founders of Spearfish Creek if you are considering using any other Western Re-enactment Groups, as well as Spearfish Creek, at the booked event, we like to know who we will be working with or camping with.**
- 6) Some times we will request that we do a site visit prior to the event if we think this is necessary.**

7) Security is very important if we are staying over night at any event, gates that lock at night are preferred or event security guards, this is due to the nature of the guns/weapons that are used for re-enactment purposes, if we arrive at an event and think the security or site are not appropriate for re-enactment then we reserve the right to leave the event. If we decide to leave any event early due to no fault of own then we will still insist that our costs are covered.

8) Spearfish Creek Re-enactment Group have Public Liability Insurance, a copy of which has been emailed to the event organiser or contact, this insurance only covers Spearfish Creek Members should a member of Spearfish Creek do something that causes injury to a member of the public, the event organisers are responsible for insuring the rest of the event.

9) We have supplied the event organisers with a copy of the groups Insurance, Health & Safety Policy and Rules, by signing this booking form you are agreeing to all of the groups rules and terms as listed on this form and all other documents that the group has supplied to you.

CANCELLATION POLICY:

14 Day Cooling off Period : You have 14 days from the date that this form was signed in which to cancel your booking, no fee will payable, after 14 days the following will apply:

We will waive all fee's if we agree that cancellation of the event or booking is beyond the control of the event organisers, this will be assessed on a case by case basis at our discretion. And we reserve the right to ask for a percentage of the booking fee if we deem it fit to do so.

Should you cancel our booking and use an alternative re-enactment group then the booking fee is to be paid in full. Example booking fee £175.00 then 100% of this is to still be paid to Spearfish Creek Re-enactment Group. Failure to comply will result in Court Action.

Any changes or extras made to the original booking will have to be agreed and additional costs if applicable will apply.
